Psychology Associate in Arts Degree for Transfer 19 – 20 units Fall 2023 Revisions: catalog description, PLOs, career opportunities, and add required courses ECON G160and SOC G125, add List B PSYC G116, add List C ETHS G167, PSYC G167, and SOC G100, and units decrease. 1st reading 02/01/22. Returned to faculty to edit effective term to Fall 2023. The proposal will be consented on the next agenda with corrections made and confirmed in technical review.

ACCT G100 – Introduction to Accounting 3 units Fall 2023 Revisions: catalog description, required for degree or certificate, SLOs, course objectives, methods of instruction, instructional techniques, course assignments, methods of student evaluation, textbooks, and **updated DE addendum**. Faculty did not attend CCI.

COUN G116 – Academic Planning for Nursing 0.5 units Fall 2023 New course. Includes new DE addendum. The committee does not recommend having a course in which students will pay for the benefits listed in the proposal and recommend the students receive academic planning for Nursing during appointments with the Counseling department. Additional recommendations include holding workshops, information sessions, or develop marketing / promotional materials.

MGMT G111 – Human Resources Management 3 units Fall 2023 Revisions: catalog description, grading policy, required for degree or certificate, SLOs, course objectives, lecture content, methods of instruction, course assignments, methods of evaluation, textbooks, and **updated DE addendum**. Faculty to add Liberal Arts Business and Public Administration, Management Certificate of Achievement, remove old Liberal Arts degrees, and be consistent throughout the proposal to use "resource" or "resources." To 2nd reading.

Business Administration (For Transfer) 16 – 17 units Fall 2023 Certificate of Achievement

New program. The committee advised the department to remove the word "transfer" in the program title as it will cause confusion for students. The committee recommends the faculty evaluate the career opportunities as there is not entry level management or administrative positions. The committee recommends the department bring this proposal back along with the other two programs to have a better understanding of the intent of programs as a whole. To 2nd reading.
