REPORTS & UPDATES (maximum of 5 minutes per report)

- 1. Articulation report Jerry Castillo ASSIST is modernizing articulation agreements by major (AAM) beginning in the 2023-24 academic year so AAMs are not up to date on ASSIST currently. Course articulations are being phased out effective Fall 2024, see AO report for details. Conditionally approved will be denied as well. Faculty are encouraged to review and modify for articulation approval. CSU GE and IGETC are being submitted by Jerry in the first week of December. Jerry asks faculty to make sure courses they want to submit are communicated to him as well.
- 2. Chairs report Monica Jovanovich and Gary Kirby Departments with an abundance of non-content related edits can come to a second technical review session to be considered for consent of future CCI meetings. This streamline process can help departments submit more than three curricula. Considerations are on a case-by-case basis.
- 3. Credit for Prior Learning Christy Banales First Districtwide CPL meeting happened a couple of weeks ago. Topics included honoring courses awarded by other institutions and already noted on transcripts. OCC's concerns regarding outside institutions awarding credit for specific programs with their accreditation standards may be different than CCCD. Dr. Serban advises workgroups to be created for consistency with all three colleges to agree upon what is accepted for CPL and be discussed in curriculum meetings. Rubrics should be created for guidance, three colleges should have a consistent GE pattern and align with Title 5 regulations. Next CPL meeting is Tuesday, November 7 at 1:30 all is welcome to join. There is a summit being held on November 3rd with the State Chancellor's Office and ASCCC has a CPL toolkit. Kay is in contact with other VPIs at different colleges in the region for job descriptions for duties, coordinator, etc.
- 4. Special reports CPL may come up at the Curriculum Alignment Taskforce.

- 1. Process of adding courses to local GE pattern Nicole Diamond (10-03-23). Nicole suggests courses that are CSU GE and / or IGETC approved by added under the same area of the local GE pattern. Courses outside of the scope that requests to be included then the course should be reviewed. Examples include activity and some CTE courses.
- 2. Offering outdated courses Kay Nguyen (10-03-23). The list of outdated courses was presented. The committee would like to discuss departments with outdated curriculum but bringing in new curriculum.

- 1. Work Experience Education and Chancellor's Office Guidance Memo Dorsie Brooks There is new Title 5 language for formerly Cooperative Work Experience. Work experience education can be offered noncredit and / or taught via distance education. Credit hour formulation has been clarified. Discipline, specific work experience, education, coursework, differentiated by TOP code, can do general work experience embedded such as automotive and business. Dorsie requests CCI to have a workgroup that can have these conversations about work experience education and lead. CCI can send out a callout for the workgroup to all departments and report to CCI. Nicole recommends including an International Students program representative as well.

There is an automatic substitution, but the concern is listing it when it's not C-ID. The department faculty has agreed to remove ECON G160 and it will be removed on the backend. MUS G139 is included incorrectly on the agenda and was meant for the Elementary Teacher Education AAT. Jodie moved to approve, Nicole seconded; motion approved. Associate in Arts Degree for Transfer approved with the removal of ECON G160 and MUS G139.
