1. Articulation Report (Jerry Castillo) Currently, 8 ETHS courses that are CSU GE approved for Area F, will be grandfathered into IGETC Area 7.

- 2. New GWC Program Form: Test Essential Academic Skills (TEAS) Preparation, Certificate of Completion. Recommended
- 3. Suspended courses to retire effective Fall 2023 Suspended courses are impacting students and articulation agreements. Suspended courses should be considered for retirement if they have not been offered or do not intend to be offered. Retired courses can be revived in the future. If courses are intended to be offered and active, then revisions are necessary and need to be presented to CCI for approval. CCI will bring the list of suspended courses to their departments to discuss retiring effective Fall 2023 or provide justification for not retiring.
- 4. Courses and the last outline revision date Per Accreditation, courses need to be reviewed every 3 (CTE courses) or 5 (non-CTE courses) years. The list provided to CCI contains all active courses with the last outline revision date. CCI is to review the list with their department and discuss the plan of actions for their courses.
