- 3. Process for auditing courses and approval form. Title 5 requires language and process for auditing courses. Counselors would like a list to reference to when students inquire approved courses. The committee is being asked for recommendations for procedures. Having a list of approved courses may be problematic for the college to maintain and update. An appropriate approach may be to have students complete an electronic form or petition. The form will include the audit language from Title 5, justification for the request to take the course by audit, rather than enrolling in the course, and the approval of the discipline faculty, Division Dean, and Vice President of Instruction. Students who audit a course occupies a seat in the classroom, which impacts other students and FTES is not generated. Faculty should be made aware of the limited circumstances under which these requests should be approved.
